### Background

The Botanical Art Prize was established using funds raised from the sale of a painting formerly owned by Lady Scott (Valerie Finnis) and Sir David Scott. Lady Scott had a great interest in horticulture and the arts, through which she supported and maintained associated charities. She requested that, following her death, her paintings collection be sold and the funds used for charitable purposes. The Trustees of the Finnis Scott Foundation recognised that a unique gap could be filled with a dedicated prize for botanical art. Applications are judged by a sub-committee of experts with knowledge of botanical art.

### Prize Criteria

The Finnis Scott Foundation offers a biennial prize to support and promote the practice of botanical painting. Aimed at groups and organisations that are looking to go beyond their day-to-day activities, the prize recognises those who have helped raise the profile of botanical art and seek to further extend their reach to new audiences. Projects might include (but are not limited to) a new education programme or the development of an existing course, exhibition, publication, event or collaborative project.

### Eligibility

Prizes are made to UK and Irish botanical art groups and organisations, not individuals. Regional and national botanical art societies, florilegium groups, independent courses, affiliated groups and other community organisations associated with teaching or promoting botanical art, may apply. Preference will be given to independent organisations and charities.

### Qualification and Proposals

To qualify, applicants must demonstrate a recent record of achievement in promoting botanical art, to the satisfaction of the judges. The judges will consider the success of previous initiatives, including budget allocation, project planning and delivery, and audience engagement, as part of the application for the new prize.

Applicants must provide a detailed submission of the intended use of the prize, to be submitted to the Botanical Art Prize Administrator by the stated deadline. Proposals should include a project plan, with anticipated costs, timings and outcomes, to be completed within 2 years of the date of the prize.

The judges are looking to reward fresh ideas, original projects and new ways of working.

A shortlist of potential candidates will be confirmed in early spring 2022, with the winning project being announced in April.

The successful candidate will be asked to keep in touch with the Administrator regarding the progress of the winning project. A report should be submitted by a date agreed with the Trustees, not more than 2 years from the date of the prize being made.

### Application Process

The application form and supporting documents should be submitted to the Administrator [botanicalartaward@finnis-scott-foundation.org.uk](mailto:botanicalartaward@finnis-scott-foundation.org.uk), not exceeding 20mb, by **31 January 2024**.

In addition to the application form, the judges require copies of:

- Evidence of a previous project that succeeded in promoting botanical art, including project brief, budget allocation, project planning and delivery, and audience engagement and images where possible.

Prize-making is within the complete discretion of the Trustees of the Finnis Scott Foundation.

Your application will be acknowledged via email. If your proposal is not eligible, you will be told this by email. All eligible applications will be assessed, and you may be asked for further information.
